**General Information:**

## Section 6 - Accidental Release Measures

---

### LARGE SPILLS:

Minor spills do not normally need any special cleanup measures. In the event of a major spill, prevent spillage from entering drains or water courses. As a minimum, wear overalls, goggles and gloves. ### SMALL SPILLS:
